**REFERENCE-YOUR LETTER NO. 10905 DATED 06 04 2022 RECEIVED ON 09 04 2022 REGARDING MY RTI APPLICATION DATED 17 02 2022 ADDRESSED TO CHIEF SECRETARY ODISHA**

**Please refer to your above-mentioned letter regarding my RTI application dated 17 02 2022 addressed to Chief Secretary Odisha related to details of favour taken by the Chief Secretaries of Odisha along with their family members from the Ministers of Government of Odisha in any form like land, flat, plot in CDA, BDA, STATE HOUSING SOCIETIES ETC from 1985 to 2022 and posts allotted after retirement to them from 1985 to 2022 and the list of all Chief Secretaries from 1985 to 2022.**

**The said RTI applications were transferred to you from GA and PG Dept vide letter no 5252 dated 23 02 2022 for supply of information and it was also instructed that it should be forwarded to any other PIO U/S 6(3) or 5(4) if it is not available with you.**

Pls refer to the letter vide no 8192 of R&DM dated 14 03 2022 to LR & GE –A Branch, Revenue & DM Dept where you were instructed to provide the information and it was also instructed that it should be forwarded to any other PIO U/S 6(3) or 5(4) if it is not available with you.

It is pertinent to mention that you have responded to the above mentioned letter and you have admitted that the INFORMATION SOUGHT IN THE RTI APPLICATION DATED 17 02 2022 IS NOT SPECIFIC SO IT IS DISPOSED OF BY YOU.

You have no authority to dispose of the RTI application as originally it was not addressed to you rather it was addressed to the Chief Secretary Odisha and it was transferred to you and by saying “INFORMATION SOUGHT IN THE RTI APPLICATION DATED 17 02 2022 IS NOT SPECIFIC SO IT IS DISPOSED OF BY YOU “ raises questions on the IQ level of the cadre officers and the PIOs who do not know the RTI Act but have been appointed as PIO and you people keep on transferring the RTI applications to irrelevant depts. and keep on wasting time and money from state treasury.

If the INFORMATION SOUGHT IN THE RTI APPLICATION DATED 17 02 2022 IS NOT SPECIFIC then why office of the Chief Secretary has transferred the same to you needs to be clarified and specifically after taking benefits from the Ministers the cadre officers have become arrogant because of the political support.

Your jurisdiction ends with a remark whether it is available with you or not and whether you have the idea or knowledge to transfer the RTI application to other Depts and not a single inch more than that to advise me to go to where to collect the information.

You have also admitted that it is not practically possible for you to collect information from all the Revenue / other state authorities and to furnish the same to me after complying them or to transfer the RTI application to all PIOs for providing the information to me.

Under the circumstances you have yourself proved that you are terribly incompetent for the job of a PIO as neither you have the capability nor the competence as well as the integrity and respect for the RTI Act so you should resign from the post of the PIO and vacate the post for somebody else who is competent to perform the duty upto the mark.

You have also advised me to make separate application to the concerned PIOs which is vague as you yourself do not know who are the PIOs then to whom I will approach; so STOP ADVISING RIDICULOUSLY WITHOUT USE OF BRAIN.

Whatever you have written to me vide the above mentioned letter; it would have been better if you would have written the same to the Chief Secretary.

You had also taken more than one and half months after receiving the letter dated 5252 dated 23 02 2022 of Deputy Secretary to Govt GA and PG Dept to understand the content of the letter and wasted that much of time and at the end of the day you have landed saying it is not your cup of tea.

**Under the circumstances you open the case and find out the relevant PIOs with whom the information sought is available and I had already given you the clue of CDA/BDA/STATE HOUSING SOCIETIES with whom you can contact about the favours taken by all Chief Secretaries from the Minister during the year 1985 to the year 2022.**

**It is also ridiculous to see that the Chief Secretary's' office is not able to provide THE LIST OF ALL CHIEF SECRETARIES FROM 1985 TO 2022 as sought in the RTI application dated 17 02 2022 after approximately lapse of two months except shifting the file to irrelevant Depts.**

**If the LIST OF ALL CHIEF SECRETARIES FROM 1985 TO 2022 is not available in the Chief Secretary's' office then God save Odisha and there cannot be more mockery than this and due to such dysfunctional Chief Secretaries the state should go for President's rule.**

**There are many grounds available to approach the Hon'ble President of India to look into the matter for imposing President's rule in the state as there is no visibility and presence of governance except distributing free rice and cash to the undeserving families under NFSA and SFSS by violating all exclusion criteria regarding which no action has been taken after my repeat complaints.**

**If a simple information about the list of Chief Secretaries sought under RTI is not provided then it can be imagined what type of cadre officers are in charge of such a poor state like Odisha whose major population both deserving and undeserving families run after the ULB officials to be enrolled under NFSA and SFSS who have compromised the AIS rules for their greed.**

**When the governance by the cadre officers are questionable then it is a good case for President's rule where AIS rule is violated and Supreme Court guidelines are compromised and it is a threat to the democracy and as a guardian of the citizens of the country, President's rule should be imposed.**
